ELIGIBILITY: Entrant must be a male amateur member of a Member Club of the St. Louis District Golf Association. The entrant must have an up-to-date and current USGA GHIN Handicap Index. This entry and Handicap must be certified by an Association or Club authorized to issue a USGA GHIN Handicap. Entries are subject to rejection at any time (including during the Championship) by the Championship Committee. The reason for rejection may include unbecoming conduct. Entrants must be 50 years of age on before August 31, 2010.

The field will be limited to the 100 applicants with the lowest USGA GHIN Handicap Indexes.

FORMAT: 36 holes at stroke play

1ST Round – 18 Holes, Tee Times

WEDNESDAY, SEPTEMBER 1

2ND Round – 18 Holes, Shot Gun Start

Awards Luncheon following completion of Tournament

There will be Prizes for Gross & Net 50-64 Seniors and Super Seniors 65 and over.

The lowest scorer for 36 holes will be the Champion. Any tie(s) for the overall Champion will be decided immediately by a sudden death hole-by-hole play-off. For all other ties see Appendix I of the USGA Rules of Golf, How to Decide Ties, Paragraph C.

PRIZES: Overall Winner: Overall winner will receive the Louis Cassett perpetual trophy for a period of one year. Some merchandise certificates will be awarded to top finishers at the discretion of the Championship Committee.

NO OTHER REMUNERATION: By this application, an entrant certifies that he is not entitled to remuneration of any kind for participation in this Championship other than the aforementioned prizes.

ENTRIES: Entrant shall apply on the attached form. \$125.00 entry fee shall be paid by every applicant. Entry Application and fees must reach the Association's Office at the address listed on the entry form by **4:00 p.m., August 19, 2010. No Refunds after the deadline.**

REGISTRATION: All players must be ready to play at appropriate starting point and published starting time.

PRACTICE PRIVILEGES: Practice privileges at Sunset Hills Country Club are extended by appointment only by calling the golf shop at 618-656-8088.

FOOTWARE: Sunset Hills Country Club is a spikeless facility. Shoes with traditionally designed spikes, comprised either partially or entirely of metal, are prohibited. Penalty for breach of this condition: **DISQUALIFICATION.**

CADDIES; AUTOMOTIVE TRANSPORTATION: A player may provide his own caddie at any time during the Championship, provided the caddie is not a participant in the Championship, or a player may carry his own clubs. Players may use automotive transportation. Entry fee includes cart fee during play.

TIME OF STARTING: The Optional Condition for Time of Starting, as set forth in Appendix 1 of the USGA Rules of Golf, shall be in effect. (See also Note under Rule 6-3).

CONDITIONS, SCHEDULES: The Championship Committee reserves the right to alter any of the conditions and schedules herein. The decision of the Championship Committee in any matter shall be final.

COMMUNICATIONS DEVICES: No communications devices of any kind shall be permitted on the course during the tournament.

RULES OF GOLF: Play will be governed by the United States Golf Association Rules of Golf.

PERSONAL APPEARANCE: During all phases of the Championship, Competitors must be neat in appearance with respect to clothing and personal grooming. The Championship Committee shall decide whether this requirement has been met and has authority to withdraw the entry of a Competitor who does not comply. The wearing of Bermuda length shorts is permitted.

Participation in this event is conditioned on Amateur Status. The USGA Rules of Amateur Status shall apply. The Championship Committee reserves the right to disqualify any participant for not having Amateur Status. Disqualifying events include (i) competing for cash prizes in any amount and (ii) competing for merchandise prizes exceeding \$750 in retail value.
